**CAMP SCHOLARSHIP APPLICATION AND INSTRUCTIONS**

The Village Club Enrichment Fund was established through the generosity of The Village Club members. Among the purposes of The Village Club Enrichment Fund is awarding scholarships and rendering financial assistance to deserving students who are current employees of The Village Club or their family members. It is intended that all scholarships be awarded in accordance with these procedures on an objective and nondiscriminatory basis. Camp Scholarships are awarded annually and apply to current-year summer sessions.

**Scholarship Eligibility**

Recipients of scholarships will be selected from “qualified applicants” based upon standards set below. To be a “qualified applicant” for a camp scholarship award, a student must be a child of a current employee and meet the following standards:

- “current employee” means an employee of The Village Club who has worked for The Village Club for a minimum of 150 hours during the 12 months immediately preceding the month of application.
- “child of a current employee” means the child or stepchild of the current employee, or a child for whom the current employee is the legal guardian.
- the child who is of camp programming ages from preschool through high school, including a student who has just completed high school in the spring of the selected summer camp session.

**Other Information**

Each scholarship is awarded for payment towards camp expenses for the summer of the current calendar year.

The number of camp scholarship awards and the amount of each award shall be determined at the sole discretion of The Village Club Enrichment Fund Board of Directors. Under no circumstances will any scholarship be awarded to any Village Club member or person who is an immediate family member of a Village Club member.
